Brief analysis: Decrease in Lifetime (-1, Jane Belt passed away), Emeritus(-3) Student (-1), and Institutional(-3); increase in Regular new(+6) and Regular renewal(+5); overall increase this year 2 members.

In winter '08 recruited renewals for Institutional members by sending invoices to institutional representatives. State reps sent reminders to individuals in their states who hadn't renewed (Susan Barnes contacted Canadians and Alaskans). Contacted four library schools to ask for nominations for free student membership and heard back from Emporia State University (Michael Graham), the University of Alberta (Diana Keto), and the University of Washington (Stacey Storem). Nice bump in new members and renewals preceding 2009 Annual Meeting early registration deadline. Early renewal drawing conducted autumn, 2008. Winners: First prize to Mary Wood (free MLA membership), second prize to Liisa Rogers (iPod Shuffle), and third prize to Emily Glenn (\$25 bookstore gift card). Investigated use of RegOnline to manage membership and as a way to accept credit card dues payments. Proposal to PNC/MLA Board that our association test RegOnline and absorb associated costs was accepted. Set up membership record and keyboarded data for all members into RegOnline system in time to be used in conjunction with registration for 2009 PNC/MLA Annual Meeting.
