Brief analysis: Increase in Lifetime (+2) and Emeritus(+3); increase in Institutional(+6); decrease in Regular new(-10) and Regular renewal(-14); overall decrease 13 fewer members. Nonrenewals included layoffs, library closures, retirement, and career changes (at least 9: Arendt, Bennett, Braun, Conn, Cunningham, Glusker, Goodwin, Kuhn, Malone). A couple seemed to have joined to attend an annual meeting (Davis, Gaudette). Other reasons for nonrenewal unknown.
